SPONSORSHIP AGREEMENT

This Sponsorship Agreement (hereinafter referred to as the "Agreement") is entered into between:

THE PEMBROKE LOCAL COUNCIL, a body established under the laws of Malta, having its offices in Pembroke, Malta (hereinafter referred to as the "Council");

and

VLADIMIR VITALYEVICH BREDIKHIN, identity card number **0115017L**, residing at **32, Sea La Vie, Fl 2, Triq il-Fortizza, Pembroke** representing **KUDO MALTA LTD**, a company duly incorporated under the laws of Malta with Registration Number C 86604 and having its registered address at Melita Football Club, Triq Sir Adrian Dingli, Pembroke PBK 1940, Malta (hereinafter referred to as the "Sponsor").

The Council and the Sponsor are hereinafter collectively referred to as the "Parties".

RECITALS

- A. The Council is undertaking an upgrade and regeneration project within the locality of Pembroke for the benefit of residents and the general public;
- B. The Sponsor has expressed its intention to contribute financially towards this project as part of its commitment to community development and corporate social responsibility;
- C. The Parties wish to regulate their relationship through this Agreement.

NOW, THEREFORE, THE PARTIES AGREE AS FOLLOWS:

1. PURPOSE OF THE AGREEMENT

- 1.1 The Sponsor agrees to sponsor part of the upgrade and regeneration project being undertaken by the Council within the locality of Pembroke.
- 1.2 The Council accepts such sponsorship and undertakes to provide the public recognition stipulated in this Agreement.

2. TERM

- 2.1 This Agreement shall come into force on 1 July 2026 and shall remain valid until 31 December 2026 unless terminated earlier in accordance with its provisions.

3. SPONSORSHIP

- 3.1 The Sponsor shall pay the Council the total sum of **Thirty Thousand Euro (€30,000)**.
- 3.2 This amount shall be paid in six (6) equal monthly instalments of **Five Thousand Euro (€5,000)** each.
- 3.3 Payments shall be made no later than the fifth (5th) day of each month during the term of this Agreement using the below listed bank details of the Council:

4. OBLIGATIONS OF THE COUNCIL

- 4.1 During the term of this Agreement, the Council shall display signs, boards or other informational material at the project site indicating that the project is being supported by Kudo Malta Ltd.
- 4.2 The Council may also acknowledge the Sponsor through its communication channels, including official social media pages, press releases and promotional material relating to the project.
- 4.3 The Council shall ensure that any reference to the Sponsor is made appropriately and in a manner that safeguards the Sponsor's reputation.

5. RECOGNITION AND PUBLIC SPACE

- 5.1 The Parties agree that any signs, boards or recognition material installed at the project site referring to the support of Kudo Malta Ltd shall be for informational and acknowledgement purposes only.
- 5.2 Nothing in this Agreement shall be construed as granting the Sponsor any exclusive right to use, occupy or exploit any public space, public property or infrastructure administered by the Council.
- 5.3 The Council shall remain free to collaborate with other sponsors, donors or entities in relation to the same project or other projects within the locality, provided that such collaborations do not unreasonably diminish the recognition granted to the Sponsor under this Agreement.
- 5.4 Any authorisation, permit or approval required by law for the installation or maintenance of the signs referred to in this Agreement shall be obtained by the Council, where applicable.

6. USE OF NAME AND LOGO

- 6.1 Each Party grants the other a non-exclusive right to use its name and logo solely for the purposes of implementing this Agreement.
- 6.2 Neither Party shall use the name, logo or any distinctive mark of the other Party for any purpose other than those contemplated by this Agreement without the prior written consent of the other Party.

7. FUTURE COLLABORATIONS

- 7.1 The Parties acknowledge that this collaboration is intended to serve as a basis for a broader relationship between them.
- 7.2 Accordingly, the Parties express their intention to explore future opportunities for collaboration, particularly in the promotion, organisation and support of sporting activities within the locality of Pembroke.
- 7.3 Nothing in this clause shall be construed as creating a legally binding obligation to enter into any future agreement.

8. REPUTATIONAL PROTECTION

- 8.1 Each Party undertakes, throughout the duration of this Agreement, to act in a manner that does not bring disrepute upon or cause substantial damage to the reputation of the other Party.
- 8.2 Should either Party become involved in any activity, investigation, proceedings or circumstances which, in the reasonable opinion of the other Party, may cause significant harm to its reputation or public image, the other Party shall be entitled to terminate this Agreement with immediate effect by written notice.
- 8.3 In the event of termination under this clause, neither Party shall be liable for any indirect damages or loss of profits allegedly suffered by the other Party.
- 8.4 Termination under this clause shall not affect any obligation that has already become due prior to the date of termination.

9. ETHICS, COMPLIANCE AND ANTI-CORRUPTION

- 9.1 The Parties declare that the execution and performance of this Agreement comply with all applicable laws of Malta.
- 9.2 The Sponsor declares that the sums paid under this Agreement constitute genuine sponsorship and are not intended to influence, directly or indirectly, any decision, contract, authorisation or other advantage.

- 9.3 The Council declares that acceptance of the sponsorship shall not create any obligation to grant preferential treatment to the Sponsor.
- 9.4 Neither Party shall offer, request or accept gifts, commissions or improper benefits in connection with this Agreement.
- 9.5 Any material breach of this clause shall constitute a material breach of the Agreement and shall entitle the other Party to terminate this Agreement with immediate effect.

10. FORCE MAJEURE

- 10.1 Neither Party shall be deemed to be in breach of this Agreement if its failure to perform any obligation is the direct result of circumstances beyond its reasonable control.
- 10.2 For the purposes of this clause, Force Majeure shall include, but shall not be limited to, natural disasters, severe weather conditions, floods, fires, epidemics, pandemics, wars, acts of terrorism, general strikes or orders issued by public authorities.
- 10.3 The affected Party shall notify the other Party in writing as soon as reasonably practicable.
- 10.4 If the Force Majeure event continues for more than sixty (60) consecutive days, either Party may terminate this Agreement by written notice.

11. TERMINATION

- 11.1 Either Party may terminate this Agreement by written notice if the other Party commits a material breach of any of its obligations and fails to remedy such breach within fifteen (15) days from receipt of written notice requiring it to do so.

12. ENTIRE AGREEMENT

- 12.1 This Agreement constitutes the entire agreement between the Parties and supersedes any prior discussions, negotiations, correspondence or agreements relating to its subject matter.
- 12.2 Any amendment or modification to this Agreement shall only be valid if made in writing and signed by both Parties.

13. GOVERNING LAW AND JURISDICTION

- 13.1 This Agreement shall be governed by and construed in accordance with the laws of Malta.
