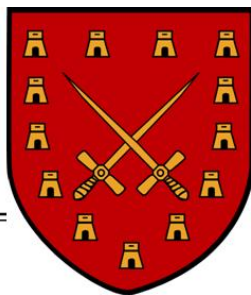

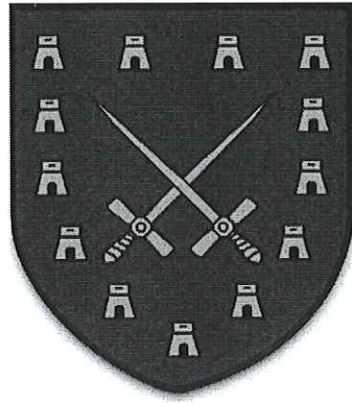

Overview and Summary

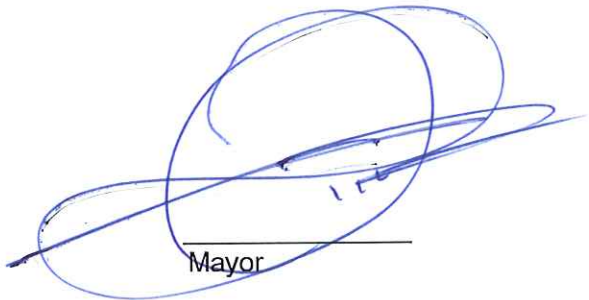
This financial report covers the period from 1 January to 30 June 2026.

During the period under review, the Council generated total income of €1,032,833, while total expenditure amounted to €903,372, resulting in an operating surplus before depreciation of €129,460.

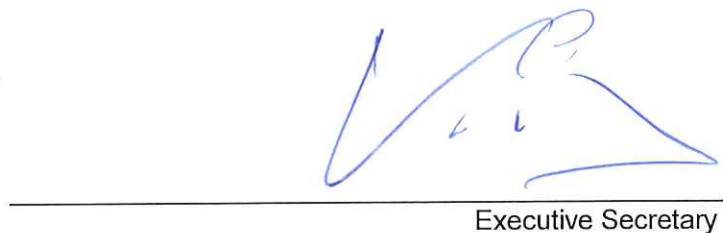
Government funds received by the Council amounted to €268,083. Income raised from the Council's own activities totalled €38,208, while General Income amounted to €726,526. The significant increase in General Income mainly relates to funding received for ongoing capital projects.

Salary and wage costs amounted to €65,595, while expenditure on Operations and Maintenance totalled €817,539, representing the Council's largest area of expenditure during the period. In addition, expenditure relating to Local/EU and Twinning Events amounted to €20,238.

Depreciation on administrative assets amounted to €1,805, resulting in an operating surplus after depreciation of administrative assets of €127,656. After accounting for depreciation on urban improvements and projects amounting to €14,022, the Council reported a surplus after total depreciation of €113,634 for the period under review.

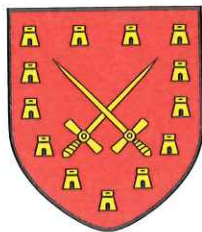
